APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee, hereby makes the following amendments to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, namely:-

AMENDMENTS.

In the said Scheme,-

1) in clause 2, in sub-clause (c), for the expression "construction or maintenance of dams, bridges, roads", the expression "construction or maintenance or **demolition** of dams, bridges, roads" shall be substituted;

2) in SCHEDULE I, after Serial Number 53 and the category relating thereto, the following shall be added namely:-

" 54. Demolition worker engaged in dams, bridges, roads or any other building"
