AMENDMENTS.

In the said Rules,-

(1) in rule 3 in clause (b),-

(a) for the expression "Joint Commissioner of Labour", the expression "Additional Commissioner of Labour", shall be substituted;

(b) for the expression "Deputy Commissioner of Labour", the expression "Joint Commissioner of Labour", shall be substituted;

(2) in rule 18,-

(a) in sub-rule (1), for the expression "Deputy Commissioner of Labour", the expression "Joint Commissioner of Labour", shall be substituted;

(b) in sub-rule (2), for the expression "Labour Officer or Inspector of Plantation", the expression "Assistant Commissioner of Labour or Assistant Commissioner of Labour (Plantation)", shall be substituted.
