In the letter second read above, the Commissioner of Labour has requested the Government to accord permission and issue suitable orders to extend the period of renewal upto 31.12.2021 for the members of Tamil Nadu Construction Workers Welfare Board and 17 other welfare boards for whom the date of renewal falls between 01.03.2021 and 31.12.2021 as one time relaxation.
