### **ORDER:**

In the Government Order first read above, the assistance for natural death of a registered construction worker payable to the nominees of the family of the deceased construction worker, registered with the Tamil Nadu Construction Workers Welfare Board, was enhanced from Rupees Fifteen thousand to Rupees Twenty thousand and the assistance to the funeral expenses of a construction worker payable to the nominees of the family of the deceased construction worker, registered with the Tamil Nadu Construction Workers Welfare Board, was enhanced from Rupees two thousand to Rupees five thousand.

2. In the Government Order second read above, the family pension payable to the nominees of the family of the deceased construction worker, registered with the Tamil Nadu Construction Workers Welfare Board, was enhanced from Rupees four hundred to rupees five hundred.

- 3. As instructed in the Government Orders first and second read above, in the letter third read above, the Commissioner of Labour has sent proposals for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme,1994 as resolved by the Advisory Committee in its meeting held on 04.11.2020.
- 4. After careful examination of the proposal of Commissioner of Labour, the Government hereby make amendments to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, so as to enhance the financial assistance for natural death, assistance to the funeral expenses of registered construction worker and family pension to nominees of the registered construction workers.
- 5. Accordingly, the appended Notification will be published in the Extraordinary issue of <u>Tamil Nadu Government Gazette</u>. The Works Manager, Government Central Press, Chennai-600 001 is requested to send ten copies of the Gazette to the Government and ten copies to the Commissioner of Labour, Chennai-600 006, directly.
- 6. The Director, Tamil Development and Information (Translations) Department, Secretariat, Chennai-600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600 001 for publication in the <u>Tamil Nadu Government Gazette</u>.

# APPENDIX. NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee hereby makes the following amendments to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 as subsequently amended.

#### **AMENDMENTS.**

In the said Scheme,-

- (1) in clause 13, in sub-clause (1-A), for the expression "Rs.400/- (Rupees four hundred only)", the expression "Rs.500/- (Rupees five hundred only)", shall be substituted;
- (2) in clause 14, in sub-clause (1), for the expression "a sum of Rs.2,000/-(Rupees two thousand only)", the expression "a sum of Rs.5,000/- (Rupees five thousand only)", shall be substituted;
- (3) in clause 14A, in sub-clause (1), for the expression "a sum of Rs.15,000/-(Rupees fifteen thousand only)", the expression "a sum of Rs.20,000/-(Rupees twenty thousand only)" shall be substituted.
