### ORDER:

Considering the second wave of COVID-19 and to protect the health of construction workers, in the letters read above, the Commissioner of Labour has requested to accord permission for the procurement and administration of 2,00,000 vaccines initially for construction workers including registered, unregistered and Interstate Migrant construction workers. He has also stated that the expenditure on procurement and administration of vaccination for 2,00,000 construction workers including registered, unregistered, Interstate Migrant construction workers and registered unorganised drivers may be met out from the funds of Tamil Nadu Construction Workers Welfare Board and from the funds of the Tamil Nadu Unorganised Drivers Welfare Board.

2. He has further stated that the subject matter on administration of vaccination will be placed before the Tamil Nadu Construction Workers Welfare Board and Tamil Nadu Unorganised Drivers Welfare Board for ratification. The expenditure towards vaccination of construction workers and unorganised drivers may be submitted by the Health and Family Welfare Department to the Commissioner of Labour. The bills shall contain the necessary particulars such as name, age, gender, address and details

of Registered / Unregistered / Interstate Migrant construction workers / unorganised drivers along with Aadhaar & mobile number, date and dosage of vaccination, place of vaccination / construction site, District name etc.,

3. The Commissioner of Labour has, therefore, requested the Government to accord permission for the procurement and administration of 2,00,000 vaccines initially for construction workers including registered, unregistered and Interstate Migrant construction workers from the funds of Tamil Nadu Construction Workers Welfare Board and also unorganized drivers in co-ordination with the Health and Family Welfare Department.

4. The Government after careful consideration have decided to accept the proposal of the Commissioner of Labour and accord permission for the procurement of vaccines to vaccinate as many construction workers including unregistered workers, Interstate Migrant construction workers and registered members of the Tamil Nadu Unorganized Drivers Welfare Board as possible irrespective of the number of workers specified by the Commissioner of Labour, in coordination with Health and Family Welfare Department / Health Agency fixed by the Tamil Nadu Medical Service Corporation and Directorate of Industrial Safety and Health, by utilizing the funds of the Tamil Nadu Construction Workers Welfare Board and Tamil Nadu Unorganized Drivers Welfare Board. The vaccine procurement and the agency to administer the vaccine would be determined by the Tamil Nadu Medical Service Corporation and the cost of vaccine and service charges for administering the vaccine would be paid to Tamil Nadu Medical Service Corporation.
