**NOTIFICATION – II.**

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu after consultation with the Advisory Committee hereby makes the following amendments to the Tamil Nadu Cooking Food Workers' Social Security and Welfare Scheme, 2015 published with the Labour and Employment Department Notification No.II(2)/LE/435/2015, at pages 518 to 556 of Part II Section 2 of the Tamil Nadu Government Gazette, dated the 5<sup>th</sup> August 2015.

**AMENDMENTS**

In the said Scheme:-

“(1) in clause 1,-

(i) in sub-clause (1), for the expression “Tamil Nadu Cooking Food Workers' Social Security and Welfare Scheme”, the expression “Tamil Nadu Cooking and Catering Workers' Social Security and Welfare Scheme, 2015” shall be substituted;

(ii) in sub-clause (3), for the expression “in all other allied activities of cooking food”, the expression “in all other allied activities of cooking food and in catering establishments” shall be substituted;

(2) in clause 2,-

(i) in sub-clause (g), for the expression “in all other allied activities of cooking food”, the expression “in all other allied activities of cooking food and in catering establishments specified in items 19 and 22 in the Schedule to the Act” shall be substituted;

(ii) in sub-clause (j), for the expression “and other allied activities”, the expression “and other allied activities and in catering establishments” shall be substituted;

(3) for the expression “Tamil Nadu Cooking Food Workers' Welfare Board” wherever it occurs including the Forms appended to the said Scheme, the expression “Tamil Nadu Cooking and Catering Workers' Welfare Board” shall be substituted;

(4) for the expression “Tamil Nadu Cooking Food Workers' Social Security and Welfare Fund” Wherever it occurs, the expression “Tamil Nadu Cooking and Catering Workers' Security and Welfare Fund” shall be substituted”.
