ORDER:

In the letter second read above, the Commissioner of Labour has sent a proposal for providing an enhanced educational assistance of Rs.2,400/- to the children of registered Construction Workers in the Tamil Nadu Construction Workers Welfare Board, studying 10th standard (Girls only) and 10th standard passed children (Boys + Girls) based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development on the floor of the Assembly on 04.09.2021 while moving the demand of this department. He has also sent a draft Notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 to this effect.

2. The Government after careful consideration, accept the proposal of the Commissioner of Labour and decided to amend the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, so as to provide enhanced educational assistance of Rs.2,400/- children studying 10th standard (Girl only) and 10th standard passed children (Boys + Girls) of registered Construction Workers in the Tamil Nadu Construction Workers Welfare Board.
