### ORDER:

In the letter second read above the Commissioner of Labour has sent the proposal for providing educational assistance for Rs.1,000/- to children of registered construction workers in the Tamil Nadu Construction Workers Welfare Board studying from class 6 to 9 based on the announcement made by the Hon'ble Minister for Labour Welfare & Skill Development on the floor of the Legislative Assembly on 04.09.2021 while moving the demand of this department. He has also sent a draft notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 to this effect.

2. The Government after careful consideration, accept the proposal of the Commissioner of Labour and decided to amend the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 so as to provide educational assistance for Rs.1,000/- to children studying from class 6 to 9 of registered construction workers in the Tamil Nadu Construction Workers Welfare Board.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee hereby makes the following amendments to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994.

**AMENDMENTS.**

In the said Scheme, - in clause 15, (1) in sub-clause (1), in the table, after the entries in Serial No.10 and the corresponding entries relating thereto the following Serial No. and the corresponding entries relating thereto shall be added, namely:-

“11    E (1)    Studying Class 6 to 9    1,000    1,000    -    -.”.

(2) for sub-clause (3), the following sub-clause shall be substituted, namely:-

“(3) The application for assistances specified in serial numbers 2 and 5 in column (1) of the Table in sub-clause (1), shall be in Form E in Schedule II, to be submitted after passing of the course, the application for assistances specified in serial numbers 6 to 10 in column (1) of the said Table shall be in Form EE in Schedule II to be submitted before completion or passing of the course, and the application for assistances specified in serial numbers 1, 3, 4 and 11 shall be in Form EEE and E(1) in Schedule II to be submitted before completion or passing of the course.”;
