NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee, hereby makes the following amendment to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, as subsequently amended.

AMENDMENT.

In the said Scheme, in clause 14A, in sub-clause (1), for the expression "a sum of Rs.20,000 (Rupees twenty thousand only)", the expression "a sum of Rs.50,000/- (Rupees fifty thousand only)" shall be substituted.
