In the letter 3th read above, the Commissioner of Labour has sent proposal based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development in the Legislative Assembly introducing an educational assistance of Rs.1000/- to the children of registered workers studying 6th to 9th Standard, enhancing educational assistance from Rs.1500/- (for day scholar) & Rs.1750/- (for hosteller) to Rs.4000/- to the children of registered workers studying regular Bachelor Degree course, enhancing Natural Death assistance from Rs.20,000/- to Rs.50,000/- and Accidental Death assistance from Rs.1,00,000/- to Rs.2,00,000/- to the registered workers of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board and to amend the Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Social Security and Welfare Scheme, 2006 to incorporate the above mentioned changes accordingly.

2. The Government, after careful examination, accept the proposal of the Commissioner of Labour to make necessary amendments to the Tamil Nadu

APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee, hereby makes the following amendments to the Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Social Security and Welfare Scheme, 2006, as subsequently amended.

AMENDMENTS.

In the said Scheme,-

- (1) in clause 17, in sub-clause (2) in item (a), for the expression "Rs.1,00,000" the expression "Rs.2,00,000" shall be substituted;
- (2) in clause 20, in sub-clause (1), for the expression "Rs.20,000/- (Rupees Twenty Thousand only)", the expression "Rs.50,000/- (Rupees Fifty Thousand only)" shall be substituted;
- (3) in clause 21,
 - (i) in sub-clause (1), in the Table,-

(a) for serial No.6 and the entries relating thereto, the following shall be substituted, namely:-

"6	XIII	Studying regular Bachelor Degree course (Every academic year)	4,000	4,000	4,000	4,000";

(b) after the serial No.10 and the entries relating thereto, the following serial No. and the entries relating thereto shall be added, namely:-

"11	XI-A	6 th to 9 th Standard studying	1,000	1,000	-	-";

(ii) for sub-clause (3), the following sub-clause shall be substituted, namely:-

(3) The application for assistances specified in serial numbers 2 and 5 in column (1) of the Table in sub-clause (1) submitted after passing of the course, shall be in Form XI; the application for assistances specified in serial numbers 6 to 10 in column (1) of the said Table shall be in Form XIII to be submitted before completion and passing of the course; the application for the assistances specified in serial numbers 1, 3 and 4 shall be in Form XII to be submitted before completion and passing of the course; and the application for assistances specified in serial number 11 in column (1) of the Table shall be in Form XI-A to be submitted before completion and passing of the course.";
