ORDER:

In the Government Order first read above, orders were issued enhancing the marriage assistance to Rs.3000/- for men and Rs.5,000/- for women, as assistance to meet the marriage expenses of the registered manual worker or of the son or daughter of the registered manual worker as the case may be.

2. In the letter second read above, the Commissioner of Labour based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development on the floor of the Assembly has sent a proposal to enhance the marriage assistance from Rs.3000/- to men and Rs.5000/- to women, to Rs.20000 to the registered construction workers in the Tamil Nadu Construction Workers Welfare Board and to amend sub-clause (1) of clause 16 of the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994.

3. Accordingly, the appended Notification will be published in the Extraordinary issue of Tamil Nadu Government Gazette. The Works Manager, Government Central Press, Chennai-600 001 is requested to send ten copies of the Gazette to the Government and ten copies to the Commissioner of Labour, Chennai-600 006, directly.

NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee, hereby makes the following amendment to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994:—

AMENDMENT.

In the said Scheme, in clause 16, in sub-clause (1), for the expression “Rs.3000/- (Rupees three thousand only) for men and Rs.5000/- (Rupees five thousand only) for women”, the expression “Rs.20,000/- (Rupees twenty thousand only)” shall be substituted.
