ORDER:

In the Government Order first read above, orders were issued to provide personal accident relief assistance of Rs.1 lakh to the nominees of registered construction workers for accidents occurring other than work site and resulting in death of the registered worker.

2. In the letter second read above, the Commissioner of Labour based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development on the floor of the Assembly on 26.04.2022 while moving the demand of this department has sent a proposal to enhance the personal accident relief from Rs.1 lakh to Rs.2 lakhs provided to the nominees of the registered construction workers for accidents occurring other than work site resulting in death of the registered construction workers and for amending the sub-clause (1) of Clause 11A of the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994. He has also sent a draft Notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 to this effect.

3. The Government after careful consideration, accept the proposal of the Commissioner of Labour and decided to amend the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994.
