ORDER:

In the Government Orders first and second read above, orders were issued for providing financial assistance for delivery of a child or for the miscarriage (or) termination of pregnancy of a registered female construction worker of the Tamil Nadu Construction Workers Welfare Board.

In the letter third read above, the Commissioner of Labour based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development on the floor of the Assembly on 26.04.2022 while moving the demand of this department has sent a proposal to enhance the maternity assistance from Rs.6,000 to Rs.18,000 provided to the female registered construction workers and for amending the sub-clause (1) of Clause 17 of the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994. He has also sent a draft Notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 to this effect.

APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by section 4 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu, after consultation with the Advisory Committee, hereby makes the following amendment to the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994:—

AMENDMENT.

In the said Scheme, in clause 17, in sub-clause (1), for item (i), the following item shall be substituted, namely:—

- “(i) Pregnancy- Rs.18,000/- (Rs.9,000/- shall be paid between seventh month to ninth month of pregnancy period and the remaining Rs.9,000/- shall be paid from two months to five months, after the delivery of the child).”.
