ORDER:

In the Government Order first read above, orders have been issued for providing educational assistance to the children of registered Construction workers with the Tamil Nadu Construction Workers Welfare Board studying ITI or Polytechnic of Rs.1000 for day scholars and Rs.1200 for hostellers.

2. In the letter second read above, based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development on the floor of the Assembly on 26.04.2022 while moving the demand of this department the Commissioner of Labour has proposed for enhancing the educational assistance to Rs.3,000/- to the children of registered Construction Workers in the Tamil Nadu Construction Workers Welfare Board, studying ITI or Polytechnic children studying (Boys + Girls) (Day scholar & Hosteller). He has also sent a draft Notification for amending the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994 to this effect.

3. The Government after careful consideration, accept the proposal of the Commissioner of Labour and decided to amend the Tamil Nadu Manual Workers (Construction Workers) Welfare Scheme, 1994, so as to provide enhanced educational assistance of Rs.3,000/- children studying ITI and Polytechnic (Day scholar & Hosteller) of registered Construction Workers in the Tamil Nadu Construction Workers Welfare Board.
