### ORDER:

In the Government Order 1<sup>st</sup> and 2<sup>nd</sup> read above, orders were issued for providing educational assistance of Rs.1,000/- (Day scholars) and Rs.1,200/- (Hostellers) per year to the children of registered workers of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board who are studying ITI or Polytechnic and maternity assistance of Rs.6000/- (Rs.3000/- between 7<sup>th</sup> month- 9<sup>th</sup> month of pregnancy period and Rs.3000 between 2<sup>nd</sup> month - 5<sup>th</sup> month after delivery of child) to the female workers of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board from 01.12.2016 respectively.

2. The Hon'ble Minister for Labour Welfare and Skill Development has made the following announcements on the floor of the Legislative Assembly on 26.04.2022:-

பெண் தொழிலாளர்களுக்கு தற்பொழுது வழங்கப்படும் மகப்பேறு நலத்திட்ட உதவித்தொகை 6,000 ரூபாயிலிருந்து 18,000 ரூபாயாக உயர்த்தி வழங்கப்படும்.

- ii. தமிழ்நாடு அமைப்புசாரா ஓட்டுநர்கள் மற்றும் தானியங்கி மோட்டார் வாகனங்கள் பழுதுபார்க்கும் தொழிலாளர்களின் குழந்தைகளுக்கு, தற்பொழுது வழங்கப்பட்டு வரும் கல்வி நலத்திட்ட உதவித்தொகை, ஐ.டி.ஐ. அல்லது பாலிடெக்னிக் படிப்பினை வீட்டிலிருந்து சென்று படிப்பதற்கு 1000 ரூபாய் மற்றும் விடுதியில் தங்கி படிப்பதற்கு 1,200 ரூபாய் ஆகியவை ஆண்டிற்கு 3,000 ரூபாயாக உயர்த்தி வழங்கப்படும்.

3. In the letter 3<sup>rd</sup> read above, the Commissioner of Labour has sent proposal based on the announcement made by the Hon'ble Minister for Labour Welfare and Skill Development in the Legislative Assembly on 26.04.2022, enhancing the maternity assistance from Rs.6000/- to Rs.18,000/- for the registered female workers and educational assistance from Rs.1,000/- (Day Scholar) and Rs.1,200 (Hosteller) to Rs.3,000/- per year to the children studying ITI or Polytechnic Course of the registered workers of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board.

4. He has also requested to issue amendments to sub-clause (1) (i) of Clause 23 and sub-clause (1) of Clause 21 of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Social Security and Welfare Scheme, 2006 respectively.

5. He has further stated that the ratification of the Board and approval of the Advisory Committee for these enhancements will be obtained once the Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board and Advisory Committee are re-constituted. The expenditure will be incurred from the own funds of the Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board.

6. The Government after careful examination accept the proposal of the Commissioner of Labour for enhancing the maternity assistance from Rs.6000/- to Rs.18,000/- for the registered female workers and educational assistance from Rs.1,000/- (Day Scholar) and Rs.1,200 (Hosteller) to Rs.3,000/- per year provided to the children studying ITI or Polytechnic Course of registered workers of Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board subject to the condition that the ratification of the Board and approval of the Advisory Committee for the same should be obtained once the Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Welfare Board and Advisory Committee are re-constituted.

7. The Commissioner of Labour is directed to send necessary proposals to issue of amendments to Tamil Nadu Unorganised Drivers and Automobile Workshop Workers Social Security and Welfare Scheme, 2006 in this regard after getting approval of Advisory Committee for these proposal.
