**NOTIFICATION.**

WHEREAS, the Governor of Tamil Nadu is satisfied that public interest requires that the “Newsprint and Paper Manufacturing Industry” should be declared as a public utility service for the purposes of the Industrial Disputes Act, 1947 (Central Act XIV of 1947);

NOW, THEREFORE, in exercise of the powers conferred by sub-clause (vi) of clause (n) of section 2 of the said Act, the Governor of Tamil Nadu hereby declares the “Newsprint and Paper Manufacturing Industry” to be a public utility service for the purposes of the said Act for a period of six months with effect on and from the date of publication of this Notification in the Tamil Nadu Government Gazette.


