#### <u>ORDER</u>

In the Government Order first read above, the Government constituted a Committee under section 5 (1) (a) of the Minimum Wages Act, 1948, (Central Act, XI of 1948) for advising them in the matter of fixing minimum rates of wages for the employment in Tabacco Manufactory (including beedi making other than Beedi Rolling). The Committee submitted its report on 30.09.1999. Industry.

2. The Government have carefully considered the recommendations of the Committee in the light of the remarks of the Commissioner of Labour and they have decided to fix the minimum rates of wages for the said employment. The Notification appended to this Government Order will be published in the <u>Tamil Nadu Government Gazette</u>.

3. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the appended Notification in English and Tamil in the <u>Tamil Nadu Government</u> <u>Gazette.</u> The Tamil Development, Culture and Religious Endowments (translation) Department, Secretariat, Chennai- 600 009 is requested to supply the Works Manager, Government Central Press, Chennai-600 079 with the Tamil Nadu translation of the Notification.

#### NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of Section 3 and sub-section (2) of Section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/LE/4406/89, dated the 9<sup>th</sup> June 1989, published at page 626 of Part II Section 2 of the <u>Tamil Nadu</u> <u>Government Gazette</u>, dated the 9<sup>th</sup> August 1989, the Governor of Tamil Nadu, after considering the advice of the Committee appointed under clause (a) of sub-section (1) of section 5 of the said Act, hereby revises the minimum rates of wages, payable to the each classes of employees in the <u>employment in Tobacco Manufactory (including Beedi making other than Beedi Rolling)</u> in the State of Tamil Nadu specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof.

#### **Explanations:-**

- (i) Each bundle consisting of 25 Beedies.
- (ii) Proportionate wages should be paid for labelling the bundles consisting of 10, 15 or 20 Beedies per bundle.
- (iii) 30% extra wages should be paid for labelling "Top Label" and Dearness Allowance should also be paid with it.

2) Ring Labelling

(For Ring Labelling Gum and thread should

be supplied by the Management)

.. Rs.5/- per 1000 Beedies

One day work means making 10,000 beedies per day.

## Explanations:

(1) **Dearness Allowance:** In addition to the Minimum Wages fixed above, the employees shall be paid Dearness Allowance as indicated below:-

(i) The Dearness Allowance in linked to the Average Chennai City Consumer price Index Number for the year 2000 i.e. 475 points (with base 1982 = 100) and for every rise of one point over and above 475 points, an increase of Rs.5/- (Rupees five only) per month shall be paid as Dearness Allowance.

(ii) The Dearness Allowance shall be calculated every year on the 1<sup>st</sup> April on the basis of the average of the indices for the preceding 12 months, namely from January to December.

(iii) The first calculation shall thus be effective from the date of publication of this Notification in the <u>Tamilnadu Government Gazette</u>, based on the average of Chennai City Consumer Price Index Number for the previous year.

(2) Where the nature of the work is the same, no distinction in the payment of wages shall be made between men and women workers.

(3) To arrive at the daily wages, the monthly wages shall be divided by 26.

(4) To arrive at monthly wages, the daily wages shall be multiplied by 30.

(5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
