APPENDIX

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 32 of the Tamilnadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamilnadu Act 33 of 1982) the Governor of Tamilnadu hereby makes the following amendments to the Tamilnadu Manual Workers (Regulation of Employment and Conditions of Work) Rules 1986.

AMENDMENTS

In the said Rules (1) After rule 20, the following rule shall be inserted, namely:-

“20-A Collection of Contribution and Remittances:

- (1) The Contribution, payable under Clause (A) of sub-section (1) of Section 8-A of the Act shall be collected by the local authority will sanctioning the building permit, by means of Demand Draft drawn in favour of the Manual Workers General Welfare Fund of the Tamilnadu Construction Workers Welfare Board, payable at Chennai. The contribution so collected by the Local Authority shall be remitted to the Tamilnadu Construction Workers Welfare Board as per sub-section (4) of Section 8-A of the Act, on or before the 15th of the month, succeeding the month in which such collections of contribution was mad along with a Statement in Form III.
- (2) The Contribution payable under clause (b) of sub-section of Section 8-A of the Act shall be remitted to the Secretary, Tamilnadu Construction Workers Welfare Board, by the person who undertakes or is in charge of the construction work, within 30 (Thirty) days from the date of commencement of such construction work. The Contribution shall be remitted as per sub-section (4) of Section 8-A of the Act by means of Demand Draft drawn in favour of the Manual Workers General Welfare Fund of the Tamilnadu Construction Workers Welfare Board, Payable at Chennai alongwith statement in Form – IV”
