### **ORDER:**

In the Government Order first read above, orders were issued to reconstitute the State Advisory Board on Contract Labour and notification has been published as Notification No. II(2)/LE/739/2012 at page 605 in the Tamil Nadu Government Gazette dated 7th November 2012. The term of the office of the non-officials in the State Advisory Board on Contract Labour Board last reconstituted in the Government Order first read above had already expired.

2. The Commissioner of Labour, in the letter second read above, has sent proposal to Government for reconstituting the State Advisory Board on Contract Labour suggesting the names of representative of members to be appointed to the Board. After considering the proposal of the Commissioner of Labour, the Government direct that the State Advisory Board on Contract Labour be reconstituted as indicated in the Notification appended to this order.

3. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the appended Notification in English and Tamil. The Tamil Development, and Information Department, Chennai-600 009 is requested to supply the Tamil translation of the notification to the Works Manager, Government Central Press, Chennai-600 079.

4. The period of the non-official members of the Board will be three years from the date of publication of notification in Tamil Nadu Government Gazette.

5. In exercise of the powers conferred by rule 10 of the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975, the Governor of Tamil Nadu hereby appoints the Assistant Commissioner of Labour (Contract Labour), Office of the Commissioner of Labour, Chennai-600 006 as the Secretary to the State Advisory Contract Labour Board.

6. The Board shall be treated as a first class Board for the purpose of drawal of Travelling allowance/Daily Allowance and the Secretary of Board will be the countersigning authority of Travelling Allowance / Dearness Allowance bills of the Non-official members of the Board.

7. The expenditure will be sanctioned in the following head of account
