In the Government Order read above, the Government have issued a preliminary notification for publishing the draft amendment to amend sub-rules (2), (3) of Rule 3, clause (b) of sub-rule (3) and sub-rule (5) of Rule 7 and Rule 15 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Tamil Nadu) Rules, 1983 so as to include the provision to facilitate the employer to submit applications and made payment through online portal of the Directorate of Industrial Safety and Health with a view to enable the environment for ease of doing business, inviting objections and suggestions from the persons likely to be affected by the amendments to the said Rules as required by the said sub*section (1) of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act 30 of 1979).

2. In letter second read above, the Director of Industrial Safety and Health has stated that the said preliminary notification has been published in Tamil Nadu Government Extraordinary Gazette No.280, in part-III 1(a), dated 31.08.2017 and also stated that no objection / suggestion has been received from anyone during the notice period and requested to confirm the above said preliminary notification.

- 3. In letter third read above, the Commissioner of Labour has sent some suggestions on the preliminary notification and requested to confirm the preliminary notification by including the suggestions sent by him.
- 4. The Government after careful consideration accept the proposal of the Director of Industrial Safety and Health and suggestions of the Commissioner of Labour and accordingly issue orders by notifying amendment to the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Tamil Nadu) Rules, 1983.
- •5. The appended notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u> both in English and Tamil.
- 6 The Director, Tamil Development and Information Department, Secretariat, Chennai-600 009 is requested to supply the Tamil Translation of the notification directly to the Works Manager, Government Central Press, Chennai-600 079.

The Works Manager, Government Central Press, Chennai 600 079 is requested to send five copies of the Gazette in which the notification published to the Principal Secretary, Labour and Employment Department, Chennai–600 009. the Director of Industrial Safety and Health, Chennai–600 032 and the Commissioner of Labour, Chennai–600 006.

APPENDIX. **NOTIFICATION**

In exercise of the powers conferred by sub-section (1) of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Services) Act, 1979 (Central Act 30 of 1979), the Governor of Tamil Nadu hereby makes the following amendments to the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Services) (Tamil Nadu) Rules, 1983, the draft of the same have been previously published as required under sub-section (1) of section 35 of the said Act.

AMENDMENTS.

In the said Rules,-

(1) in rule 3,-

- in sub-rule (2), after the expression, "by a treasury receipt", the (a) expression "or by proof of online payment through the online portal of the Directorate of Industrial Safety and Health or proof of online payment through online portal of the Commissionerate of Labour "
- shall be inserted:
- for sub-rule (3), the following sub-rule shall be substituted, namely:-(b)
 - "(3) Every application referred to in sub-rule (1) shall be made through online portal of the Directorate of Industrial Safety and Health or through online portal of the Commissionerate of Labour or personally delivered to the registering officer concerned or sent to him by registered post.";

(2) in rule 7,-

- in sub-rule (3) for clause (b), the following clause shall be (a) substituted, namely:-
- "(b) Every such application shall be made through online portal of the Directorate of Industrial Safety and Health or shall be made through online portal of the Commissionerate of Labour or personally delivered to the licensing officer concerned or sent to him by registered post.";
- in sub-rule (5), after the expression, "by rule 20", the expression "or (b) by proof of online payment through online portal of the Directorate of

Industrial Safety and Health or proof of online payment through online portal of the Commissionerate of Labour" shall be added;

(3) in rule 15, after sub-rule (2), the following sub-rule shall be inserted, namely:-

"(2A) The application referred to in sub-rule (2) shall be made through online portal of the Directorate of Industrial Safety and Health or through online portal of the Commissionerate of Labour or personally delivered to the licensing officer concerned or sent to him by registered post:

Provided that such application shall be accompanied by a treasury receipt or by proof of online payment through the online portal of the Directorate of Industrial Safety and Health or proof of online payment through online portal of the Commissionerate of Labour, evidencing the payment of appropriate fee.";
