## Amendments to the Tamil Nadu Trade Unions Regulations under the Trade Unions Act.

[G.O.Ms. No. 64, Labour and Employment (K2), 4th April 2017, பங்குனி 22, துன்முகி, திருவள்ளூர் ஆண்டு-2048.]

No.II(2)/LE/260/2017.—In exercise of the powers conferred by section 29 of the Trade Unions Act, 1926 (Central Act XVI of 1926), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Trade Unions Regulations, 1927, the draft of the same have been previously published as required by Section 30 of the said Act.

### AMENDMENTS.

In the said regulations,-

(1) in clause 14, for the expression "Rs. 100/- (Rupees one hundred only)", the expression "Rs. 1000/- (Rupees one thousand only)" shall be substituted;

(2) in clause 15, in sub-clause (2), for the expression "Rs.25/- (Rupees twenty five only)", the expression "Rs.250/- (Rupees two hundred and fifty only)" shall be substituted.
