### **ORDER:**

In the letter first read above Commissioner of Labour has proposed to hand over the implementation of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970) in respect of building and other construction activities to the Directorate of Industrial Safety and Health.

In the letter second read above Director of Industrial Safety and Health has sent proposals for notifying the officials of Directorate of Industrial Safety and Health (Building and Other Construction Workers wing) as registering officers, licensing officers and inspectors under the Contract Labour (Regulation and Abolition Act), 1970, (Central Act 37 of 1970) in respect of all establishments covered under Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act 27 of 1996).

3. After careful examination of the proposal of Director of Industrial Safety and Health, the Government hereby notify the officials of Directorate of Industrial Safety and Health (Building and Other Construction Workers wing) as Appellate Officer / Registering Officers / Licensing Officers / Inspectors under the said Contract Labour (Regulation and Abolition Act), 1970 (Central Act 37 of 1970).
